

General Terms and Conditions of Purchase

Aellia (Worldwide)

Version 2026 09 17

1. Applicability

- 1.1. These General Terms and Conditions of Purchase apply to any Contract between Aellia and the Vendor.
- 1.2. Any general terms and conditions of the Vendor, whether attached to or referred to in any offer or quotation of the Vendor, or communicated to Aellia in any other way, are expressly rejected by Aellia and do not apply to the Contract.

2. Definitions

These General Terms and Conditions of Purchase use the following definitions:

- (a) **Connected Persons** means those directors, officers, employees, subcontractors, agents, consultants and professional advisers of a Party who are involved in the supply of Goods or Services.
- (b) **Contract** means the legal relationship between Aellia and the Vendor regarding the supply of Goods and/or the performance of Services, comprising (i) the Purchase Order; (ii) these General Terms and Conditions; and, if applicable, (iii) the written agreement between Aellia and the Vendor setting out specific terms and conditions regarding the supply of Goods or performance of Services. The Contract shall in any case exclude any general terms and conditions of the Vendor and any specific terms and conditions set out by the Vendor in its offer to Aellia, except to the extent the Parties have agreed otherwise in writing.
- (c) **Damages** means losses, damages, costs (including reasonable legal costs), third party claims, liabilities and expenses (including taxation).
- (d) **Goods** means any goods or equipment to be sold, leased or otherwise supplied by the Vendor to Aellia, as specified in the Contract.
- (e) **Intellectual Property Rights** means patents, utility models, rights to inventions, copyright and related rights, trademarks and service marks, business names and domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off or unfair competition, rights in designs, rights in computer software, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets), and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or

equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world.

(f) **Aellia** means Aellia Belgium NV, a public limited liability company incorporated under the laws of Belgium with its registered office at Poeierstraat 14, 2490 Balen, Belgium and registration number BE 0452.387.313, Aellia Germany GmbH, a private limited liability company incorporated under the laws of Germany with its registered office at Werksengelände DOW, Gebäude B18, 06258 Schkopau, Germany, registered with the Local Court (Amtsgericht) of the Hanseatic City of Stendal under commercial register number HRB 213168; Aellia Netherlands B.V., a private limited liability company incorporated under the laws of the Netherlands with its registered office at Toermalijnring 528, 3316 LC Dordrecht, the Netherlands, registration number (KVK) 51909545 and VAT number NL850223246B01; Aellia Finland Oy, a private limited liability company incorporated under the laws of Finland with its registered office at Esterinportti 1, 00240 Helsinki, Finland and registration number 2651724-3; Aellia Romania SRL, a private limited liability company incorporated under the laws of Romania with its registered office at Bulevardul București 66, 3rd Floor, Ploiești, 100520, Romania, registration number J2024018018000 and Tax ID (CUI) number 50466849; Aellia France SAS, a simplified joint-stock company incorporated under the laws of France with its registered office at 69 Rue du Rouet, Marseille, 13008 France and registration number 993 506 708, or such other member of the Intero Group acting as Party to the Contract. Aellia and each of its Affiliates are together referred to as the "**Aellia Group**".

(g) **Aellia Code of Conduct** means the Code of Conduct of the Aellia Group as published at www.aellia.com.

(h) **Intero Group** means Aellia Belgium NV and all of its affiliates worldwide, including but not limited to Intero Integrity Services B.V., a limited liability company incorporated under the laws of the Netherlands with its registered office address at Steenoven 2-6, 4196 HG Tricht, the Netherlands, and its subsidiaries.

(i) **Parties** means Aellia and the Vendor, and each a Party.

(j) **Price** means the price for the Goods or Services, as specified in the Contract.

(k) **Purchase Order** means the written purchase order whereby Aellia orders Goods or Services from the Vendor.

(l) **Services** means any services to be performed by the Vendor for Aellia, as specified in the Contract.

(m) **Vendor** means the (legal) person(s) supplying the Goods or Services.

3. Performance

The Vendor shall supply the Goods or Services in accordance with the terms, specifications and deadlines set out in the Contract.

4. Variations

- 4.1.** Aellia shall have the right to make variations to the Contract at any time by written notice to the Vendor. Any such variation shall be based on a valid and objective reason, which Aellia shall state in the written notice. The Vendor shall not make any variation except with the written approval of Aellia.
- 4.2.** Variations shall not give rise to a Price increase or extension of time, except to the extent that (i) the Vendor has made a written proposal to Aellia with respect to a Price increase or extension of time prior to its performance of the variation and (ii) Aellia has accepted that proposal in writing.
- 4.3.** To the extent that a variation gives rise to a decrease in the supply of Goods or Services, the Price shall be reduced accordingly.

5. Inspection

Aellia is at all times and at any place entitled to perform or procure the performance of inspections, tests and audits with respect to the Goods or Services. Any such inspection shall not release the Vendor from any obligation, warranty or liability under the Contract.

6. Price and payment

- 6.1.** The Price shall be fixed and not subject to any price increase or surcharge.
- 6.2.** The Price is inclusive of all (third party) costs and expenses, proper packaging, inspections, tests, certificates, (un)loading and transport charges, cost of insurance, duties, taxes, social security or other statutory deductions or contributions, required permits, (compliance with) safety instructions, and any other items specified in the Contract or which Aellia may reasonably expect to be included in the Price.
- 6.3.** The Vendor shall invoice Aellia after written acceptance by Aellia of delivery of the Goods or completion of the Services. Aellia shall provide such written acceptance, or a reasoned rejection, within thirty (30) calendar days of delivery of the Goods or completion of the Services, failing which the Goods or Services shall be deemed accepted for the purpose of this clause 6.
- 6.4.** The Vendor's invoices shall conform to the requirements specified in the Contract, be properly supported and comply with any written instructions given by Aellia regarding the submission of invoices.
- 6.5.** The term for payment by Aellia of the Vendor's invoice shall be sixty (60) days from receipt of properly supported, undisputed invoices. This clause 6.5 is without prejudice to any statutory late payment interest and fixed compensation for recovery costs to which the Vendor may be entitled by mandatory law in the event of late payment.
- 6.6.** Payment by Aellia of an invoice, disputed or undisputed, shall not constitute a waiver of Aellia's right subsequently to audit, or otherwise dispute the amount or correctness of such invoice, and to obtain reimbursement.

7. Delivery and transport of Goods

7.1. Delivery of Goods shall take place on the basis of the Incoterms® 2020 rule DDP (Delivered Duty Paid), or such later version of the Incoterms rules as is in force at the date of the Contract.

7.2. The Goods must be marked to Aellia's instructions and must be properly packed according to the requirements of transport and destination and in compliance with applicable regulations. The Goods shall be packed in a way to prevent damage or deterioration during transport.

7.3. The Vendor is responsible for obtaining all applicable certificates and all necessary approvals, import licenses, custom clearing and satisfy all excise duties.

7.4. Any partial or early delivery of Goods shall require Aellia's prior written approval.

8. Warranty on Goods

8.1. The Vendor warrants that all Goods supplied are first class in terms of design, construction, performance, material, composition and quality in accordance with drawings, other documentation and the standards and specifications used by Aellia, fit for the intended use, safe and in conformity with applicable laws and regulations, and free from any defects in terms of design, construction, material or manufacturing.

8.2. The Vendor warrants that the Goods are not subject to any retention of title or any other (limited) rights of third parties. Upon request, Vendor shall deliver proof of its full and unencumbered title to the Goods.

8.3. The warranty period for purchased Goods shall be two (2) years from the date of delivery. Within this period, upon notification by Aellia, the Vendor is required to promptly arrange for repair of any failure or defect or redelivery at no charge and without prejudice to Vendor's liability under the Contract.

8.4. If pursuant to this clause 8, any Goods are replaced, repaired or altered, the full two (2) year warranty period shall again apply to such replaced, repaired or altered Goods.

9. Termination for convenience

9.1. Aellia may, by giving written notice to the Vendor, terminate the Contract for convenience, or postpone, suspend or cancel any part of the supply of Goods or Services, in each case with immediate effect.

9.2. In case of early termination or cancellation pursuant to clause 9.1, Aellia shall pay the Vendor for any Goods and Services supplied up to the date of termination or cancellation, but not for any Goods or Services that were to be supplied thereafter. No fees or penalties shall apply for cancellation or termination.

9.3. In case of any postponement or suspension pursuant to clause 9.1, the Price shall remain unchanged, and no fees or penalties shall apply for the delay.

9.4. Aellia shall compensate the Vendor for any reasonable costs actually incurred by the Vendor directly resulting from any early termination, postponement, suspension or cancellation pursuant to clause 9.1.

10. Termination for cause

10.1. Without affecting any other right or remedy available to it, Aellia may terminate the Contract, or postpone, suspend or cancel any part of the supply of Goods or Services, with immediate effect by giving written notice to the Vendor if:

- (a) an agreed date for supply of Goods or Services is not met. Such date is of the essence and if it is not met, the Vendor shall be automatically in default, without any notice of default being required;
- (b) the Vendor commits a breach of any other term of the Contract and (if such a breach is remediable) fails to remedy that breach within 14 calendar days of written notification of the breach;
- (c) the Vendor commits a breach of the Aellia Code of Conduct or any applicable laws and regulations;
- (d) the Vendor takes any step or action in connection with its entering administration, provisional liquidation or any arrangement with its creditors (other than in relation to a solvent restructuring), being wound up (whether voluntarily or by order of the court, unless for the purpose of a solvent restructuring), having a receiver appointed to any of its assets or ceasing to carry on business or, if the step or action is taken in another jurisdiction, in connection with any analogous procedure in the relevant jurisdiction;
- (e) the Vendor suspends, or threatens to suspend, or ceases or threatens to cease to carry on all or a substantial part of its business; or
- (f) the Vendor's financial position deteriorates to such an extent that in Aellia's reasonable opinion, the Vendor is no longer capable to adequately fulfil its obligations under the Contract.

10.2. The Vendor shall be liable for any Damages incurred by Aellia in connection with any breach mentioned in clause 10.1, including but not limited to (i) the cost of remediation or replacement of any defective performance by the Vendor and (ii) the costs associated with procuring the non-supplied Goods or Services from a third party vendor.

11. Liability and indemnity

11.1. Subject to clause 11.2, Vendor indemnifies and holds harmless each member of the Aellia Group and its Connected Persons for any Damages arising in connection with the performance of the Contract by the Vendor and its Connected Persons.

11.2. The Vendor shall not be liable towards any member of the Aellia Group or its Connected Persons for consequential damages including loss of profits, loss of sales, business or production, loss of anticipated savings, loss of or damage to goodwill, except to the extent caused by the willful misconduct or gross negligence of the Vendor or any of its Connected Persons.

11.3. Aellia shall not be liable towards the Vendor or its Connected Persons for any Damages arising in connection with the performance of the Contract by Aellia and its Connected Persons, except (i) for its obligation to pay the Price in accordance with the Contract; and (ii) to the extent such Damages are caused by the willful misconduct or gross negligence of Aellia or any of its Connected Persons.

11.4. The Vendor is obliged to obtain adequate and fully paid up insurance from a reputable insurer to cover its obligations under the Contract and applicable laws and regulations. Upon request, the Vendor shall present Aellia with evidence of such insurance and/or add Aellia as a beneficiary of such insurance.

12. Compliance

12.1. In performing its obligations under the Contract, the Vendor shall (i) comply with all applicable laws and regulations and (ii) adhere to the Aellia Code of Conduct. The Vendor shall sign an ethical commitment to the Aellia Code of Conduct on request.

12.2. The Vendor represents and warrants that neither it, nor any of its Connected Persons, is subject to any applicable trade or economic sanctions, and that the Goods, Services and any related technology comply with applicable export control and sanctions laws and regulations, including those of the European Union, Belgium and, where relevant, the United States. The Vendor shall promptly notify Aellia if it becomes aware of any circumstance that may affect the accuracy of this warranty.

12.3. The Vendor shall not, directly or indirectly, offer, promise, give or authorise the giving of anything of value to any person for the purpose of improperly influencing any act or decision in connection with the Contract, and shall otherwise comply with all applicable anti-bribery and anti-corruption laws and regulations.

13. Intellectual Property Rights

13.1. The Vendor warrants that the Goods or Services do not infringe Intellectual Property Rights of any third party and indemnifies and holds harmless each member of the Aellia Group and its Connected Persons for any Damages incurred in connection with any such infringement.

13.2. The Vendor grants to each member of the Aellia Group, or shall procure the direct grant to each member of the Aellia Group of, a fully paid-up, worldwide, non-exclusive, royalty-free, perpetual and irrevocable license to copy and modify the Goods for the purpose of receiving and using them in its business.

13.3. All Intellectual Property Rights in or arising out of or in connection with the performance of Services shall be owned by the Aellia Group.

14. Data protection and data processing

14.1. The Vendor shall comply with all requirements of applicable data protection laws and regulations.

14.2. Without prejudice to the generality of clause 14.1, the Vendor shall, in relation to any personal data requested and processed by it in connection with the Contract:

- (a) ensure that it has in place appropriate technical and organizational measures to protect against unauthorized or unlawful processing of personal data and against accidental loss or destruction of, or damage to, personal data;
- (b) ensure that all personnel who have access to or process personal data are obliged to keep the personal data confidential; and
- (c) not transfer any personal data outside of the European Economic Area unless the prior written consent of Aellia has been obtained, an appropriate transfer mechanism recognised under applicable data protection law (such as an adequacy decision, standard contractual clauses or binding corporate rules) has been put in place, and the Vendor complies with reasonable instructions given by Aellia as a condition for its consent;
- (d) assist Aellia, in responding to any request from a data subject and in ensuring compliance with its obligations under applicable data protection laws with respect to security, breach notifications, impact assessments and consultations with supervisory authorities or regulators;
- (e) notify Aellia without undue delay on becoming aware of a personal data breach;
- (f) at the written direction of Aellia, delete or return personal data and copies thereof to the Vendor on termination of the Contract unless required by applicable law or regulation to store the personal data; and
- (g) maintain complete and accurate records and information to demonstrate its compliance with this clause 14; and
- (h) make available to Aellia all information necessary to demonstrate compliance with this clause 14 and allow for, and contribute to, audits or inspections conducted by Aellia or an auditor appointed by Aellia, on reasonable prior notice.

14.3. Aellia does not consent to the Vendor appointing any third party processor of personal data under the Contract.

15. Confidentiality

15.1. The Vendor undertakes that it shall not disclose to any person any confidential information concerning the business, services, affairs, customers or suppliers of the Aellia Group, except as permitted by clause

15.2. Confidential information shall include but not be limited to the information provided by Aellia to enable the Vendor to fulfill its obligations in connection with the Contract, except where written records show that such information was already public knowledge or in the possession of the Vendor prior to receipt thereof from Aellia.

15.2. The Vendor may disclose confidential information:

(a) to its Connected Persons, provided that the Vendor shall ensure that its Connected Persons comply with this clause 15; and

(b) as may be required by law, a court of competent jurisdiction or any governmental or regulatory authority.

15.3. The Vendor shall not use the confidential information for any purpose other than to perform its obligations under the Contract.

15.4. The Vendor shall return, destroy or erase from its systems any confidential information at the first request of Aellia.

16. Subcontracting

The Vendor shall not subcontract any of its obligations under the Contract to any third party without the prior written consent of Aellia.

17. Assignment

The Vendor shall not assign or transfer any of its rights or obligations under the Contract to any other person without the prior written consent of Aellia. Aellia is entitled to assign its rights under the Contract to any other person without prior consent of the Vendor.

18. Severance

If any provision or part-provision of the Contract is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this clause 18 shall not affect the validity and enforceability of the rest of the Contract.

19. Notices

Any notice given to a Party under or in connection with the Contract shall be in writing and shall be delivered by hand or by pre-paid first-class post or other next business day delivery service at its registered office; or sent by email to the address specified in the Purchase Order or written agreement between the Parties, as the case may be.

20. Third party rights

The Contract shall not grant any right to persons who are not a Party. To the extent the Contract expressly grants rights to third parties, the Parties shall be permitted to change or exclude such rights at any time without the consent of the respective third party.

21. Governing law

The Contract, and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of Belgium. The applicability of the United Nations Treaty Convention on Contracts for the International Sale of Goods (Vienna Sales Convention) is expressly excluded.

22. Jurisdiction

Each Party irrevocably agrees that the district courts of Turnhout, Belgium have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with the Contract or its subject matter or formation.

23. Force Majeure

Neither Party shall be liable for any failure or delay in performing its obligations under the Contract to the extent that such failure or delay is caused by an event beyond its reasonable control, including but not limited to acts of God, war, terrorism, riot, civil commotion, epidemic or pandemic, governmental action, or failure of public utilities or transport networks (a "Force Majeure Event"). The Party affected by a Force Majeure Event shall promptly notify the other Party in writing and shall use reasonable efforts to mitigate its effects. If a Force Majeure Event prevents a Party from performing its obligations for a continuous period of more than sixty (60) days, either Party may terminate the Contract by written notice, without liability to the other Party save for obligations accrued prior to the Force Majeure Event.

24. Passage of Title

Title to the Goods shall pass to Aellia upon delivery in accordance with clause 7.1, or upon payment of the Price, whichever occurs earlier. Risk in the Goods shall pass in accordance with the Incoterms rule referred to in clause 7.1.
